RE: Legal Opinion Regarding Alley Vacation

Date: March 25, 2015

I am at the public hearing on the Mediterranean Village item, and a resident, Mr. Orlando Capote, presented me today with the attached letter from the Inspector General. I will be making a statement regarding the letter on the record today. I just wanted to make you aware, as a courtesy and as counsel for the Inspector General's Office, that I agree with the Inspector General that there is no jurisdiction by the IG over this matter, but disagree that the City's decision whether to vacate an alley is governed by the County Code or subject to County approval. My opinion is that the vacation of an alley held by the City for the benefit of the public, which the City is treating as a quasi-judicial matter but which also has a proprietary component (as the City owns the alley), is exclusively governed by section 62-264 of the City's Municipal Code and section 3-1203 of the City's Zoning Code. The City need not receive the approval of the County as to whether to vacate a City alley, and the City's Public Works Director has indicated to me that, to the best of his knowledge, the County has not asserted such a right to approve a City alley vacation in the past (Glenn, please provide any further information you would like). I plan to provide this opinion at the hearing today pursuant to my authority to issue opinions and interpretations as City Attorney (section 2-201(e)(1) and (8) of the City Code, and section 2-702 of the City's Zoning Code). I just wanted to make you aware of this.

Of course, I would like to emphasize that the City will obtain any necessary County approvals related to the traffic plan as it relates to streets and the flow of traffic for this project.


Dear Mayor Cason:
