23 C. Conditional uses. The following uses are permitted in the CL District as conditional uses, if
24 approved under the provisions of Article 3, Division 4, subject to the standards in this
25 Section and other applicable regulations in Article 5:

27 1. Assisted living facilities.

29 2. Automobile service stations (reconstruction only).

33 4. Drive-through facilities if not adjacent to SFR or MF1 districts.

35 5. Educational facilities of greater than fifty (50) student seats.

37 6. Medical clinic greater than ten-thousand-five-hundred (10,500) square feet of floor area
38 when adjacent to an SFR, MF1, MF2, or MFSA district.

42 8. Nighttime uses within one-hundred-fifty (150) feet of a parcel of land designated as a
43 residential districts.
