RE: Legal Opinion Regarding Release of Covenant - 299 Alhambra Circle

Date: May 2, 2017

Further to your email and as discussed, the Covenant preventing the separate conveyance of the office building at 299 Alhambra Circle and a surface parking lot at the corner of Salzedo Street and Minorca Avenue should be released by our office. In sum, the property owner has requested the release of a Covenant and has submitted an affidavit attesting that he has no personal knowledge as to why the Covenant was recorded against the property; that the office building is under contract for sale; and that the Covenant can adversely impact his financial interest and may cause liability issues if the sale and purchase agreement are terminated. Additionally, the owner's counsel submitted a letter explaining why the Covenant should be released.

City staff has not been able to determine any basis for requiring that the parking lot and office building be linked. Notably, while the Covenant provides that the office building and the parking lot site cannot be conveyed separately, it does not require that the property at Salzedo and Minorca be used as a parking lot. The five-story office building was constructed in 1958 without off-street parking and because it was built before 1964 and has not been enlarged, it is exempt from the City's off-street parking requirements. Thus, because the City cannot determine any reason why this covenant may have been required and it does not appear to have been proffered in conjunction with any request, there does not seem to be any rational basis for retaining the Covenant and, as a legal matter, it should be released. Additionally, the property owner has provided a General Release of any and all claims against the City related to this matter, which serves as consideration for the release of the Covenant as settlement of any potential claims or disputes.

Accordingly, I will execute the Release of Restrictive Covenant tomorrow.


