RE: Legal Opinion Regarding Noise Ordinance and the use of generators

Date: November 1, 2019

I have looked into this matter based on your email from yesterday. Sec. 34-170(3) was part of the rewrite of this Code section which occurred in early 2016 (Ordinance No. 2016-18). Based on the transcript from the first and second reading of the Ordinance, it is my opinion that the provision applies only to noise made during the testing of backup generators or during a state of emergency (i.e. hurricane, etc.). During the February 23, 2016 City Commission meeting, in introducing the item, the then-City Attorney explains that the addition of subsection (3) to the draft ordinance was made in order to provide, "relief for emergency backup energy generators during a state of emergency." During the March 15, 2016 City Commission meeting, the City Attorney again makes the point clear in stating: "The Mayor wanted me to mention about generators during emergencies, in states of emergency or a major storm event or something like that, the Code does exempt them."

Based on the transcript of the two meetings, it is clear that the Commission's intent was to exempt backup generators from the noise ordinance for purposes of testing and during a state of emergency, but not in their entirety.

This opinion is issued pursuant to Sec. 2-252(e)(1) and (8) of the City Code.
