The Procurement Division advertised RFQT 2025-002 for Canopy Structure with Shade – Fabrication and Installation on January 21, 2025. A total of one hundred-five (105) firms were notified through INFOR, the City's web-based e-Procurement system. On January 31, 2025, a total of three (3) responses to the RFQT were received by the following bidders: Atlantic Awnings & Metal Works, Inc., Awnings Universal, Inc., and Eventstar Structures, Corp.

The responses were reviewed by the Procurement Division to determine responsiveness to the requirements of the RFQT and to identify the lowest priced bidder.

The Procurement Division finalized its due diligence process and confirmed that Awnings Universal, Inc., is both responsive to the requirements of the RFQT and a responsible bidder. As such, my recommendation in accordance with Section 2-763 of the City Code entitled "Contract Award", for award of the subject RFQT is as follows:

- 1) Accept the recommendation to award Awnings Universal, Inc., the lowest responsive and responsible bidder, to provide Canopy Structure with Shade - Fabrication and Installation.
- 2) Execute a contract with Awnings Universal, Inc., in the estimated total amount of \$73,300.00.
- 3) Reaffirm the city's right to pursue alternative courses of action.
