I met with Officer Denham this morning regarding your below questions. To clarify, a custodian of records is not required to give out information from the records of his or her office. *See Op. Att'y Gen. Fla. 80-57 (1980)*. Nor does the Public Records Act require a municipality to produce an employee to answer questions regarding its records. *See Op. Att'y Gen. Fla. 92-38 (1992)*. Thus, because Chapter 119 does not impose a duty to answer questions about City records, the City will construe your below questions as additional public records requests; therefore, to the extent that there are records responsive to your requests they will be provided to you - as soon as practicable- after payment of the 50% deposit permitted under Chapter 119. As such, the City will be in contact with you to advise you of the amount required for the 50% deposit as well as to provide you with a timeline for production of the responsive records. Finally, please note that all payments must be made by ***certified check or money order not personal check***. Our Office accepted your last payment in the form of a personal check as a courtesy in light of your deadline, but City policy requires a certified check or money order - as outlined in the attached Optional Public Records Request Form.
